### **Horizontal Placement/Movement (Article 3.13 and 3.15)**

- Column 1 Bachelor's degree or partial fulfillment of a Life Instructor's Credential in a vocational related discipline.
- <u>Column 2</u> Master's degree or clear Life Instructor's Credential in a vocational related discipline with a Bachelor's degree.
- <u>Column 3</u> Master's degree plus 30 semester units subsequent to the date of the Master's degree, or Bachelor's degree plus 60 semester units with Master's degree, or clear Life Instructor's Credential in a vocational related

discipline with a Bachelor's degree and 60 semester units subsequent to the date of the clear Life Instructor's Credential in a vocational related discipline.

<u>Column 4</u> - Master's degree plus 60 semester units subsequent to the date of the Master's degree or Bachelor's degree plus 90 semester units with Master's degree.

**Column 5** - Earned Doctorate.

### **Vertical Placement/Movement (Article 3.13-3.14)**

- 1. Step 14 is the highest entering step for permanent/probationary unit members as provided for in Article 3.13.2, except as provided therein.
- 2. Step 9 is the highest entering step for temporary unit members as provided for in Article 3.13.2.
- **4.** All temporary instructors may not advance beyond Step 16 as provided for in Article 3.14.3.

### **Doctorate Bonus (Article 3.12)**

1. A \$1,000 bonus is paid once for receiving earned Doctorate from an accredited institution while employed by the District. Any regular contract employee receiving such an award must agree to remain under contract to the District for two years after the award is granted.

### **Contract Payment Calculations (Articles 3 and 8)**

### 1. TEMPORARY PART-TIME CREDIT INSTRUCTOR PAYMENT FORMULA (Article 3.2):

Annual salary x # of units divided by 30 units <math>x 95% = Semester payment divided by 5 = Monthly salary.

### 2. a. OVERLOAD CREDIT INSTRUCTOR PAYMENT FORMULA (Article 3.7):

Annual salary (but not to exceed step 20) x # of units divided by 30 units x 95% = Semester payment divided by 5 = Monthly salary.

# b. OVERLOAD, INTERSESSION, AND PART-TIME TEMPORARY CREDIT NON-INSTRUCTIONAL ASSIGNMENTS (INCLUDING LIBRARIANS AND SCHOOL NURSES) PAYMENT FORMULA (Article 8.5.4):

Hours to be worked divided by total semester hours per unit (43.75) equals the number of units of the assignment. Then apply the appropriate Temporary Part-Time Credit Instructor Payment Formula or Overload Payment Formula as above, or Intersession/Summer Session Payment Formula as below. This section does not apply to counselors.

### c. OVERLOAD AND TEMPORARY COUNSELOR PAYMENT FORMULA (Article 8.11):

Forty (40) hours of assigned time per unit. Then apply the appropriate Temporary Part-Time Credit Instructor Payment Formula or Overload Payment Formula as above.

### 3. INTERSESSION/SUMMER SESSION CREDIT INSTRUCTOR PAYMENT FORMULA (Article 3.9):

Annual salary x # of units divided by 30 units <math>x 95% = Total payment.

## 4. TEMPORARY NON-CREDIT UNIT MEMBERS WORKING THE SEMESTER PROGRAM ON-CAMPUS (EXCEPT ESL AND IEP - SEE ABOVE) (Article 3.3):

**Lecture:** First determine credit salary step and column. Then hours per semester divided by 350 rounded to 4 decimal places x 15 units = units. Then Annual Salary x number of units divided by 30 units x 80% = Semester Payment divided by 5 = Monthly Salary.

### **UPM/AFT Salary Schedule (Continued)**

**Lab:** First determine credit salary step and column. Then hours per semester divided by 525 rounded to 4 decimal places x 15 units = units. Then Annual Salary x number of units divided by 30 units x 80% = Semester Payment divided by 5 = Monthly Salary.

### 5. SUBSTITUTE INSTRUCTOR PAY RATES (Article 3.6) for:

- (a) Credit Faculty and
- (b) Non-Credit Faculty referenced in number 4above:

The current short-term substitute rate is the Stipend Rate of \$74. Long-term substitutes shall be paid on the salary schedule as prorated for the assignment. (See Article 6)
